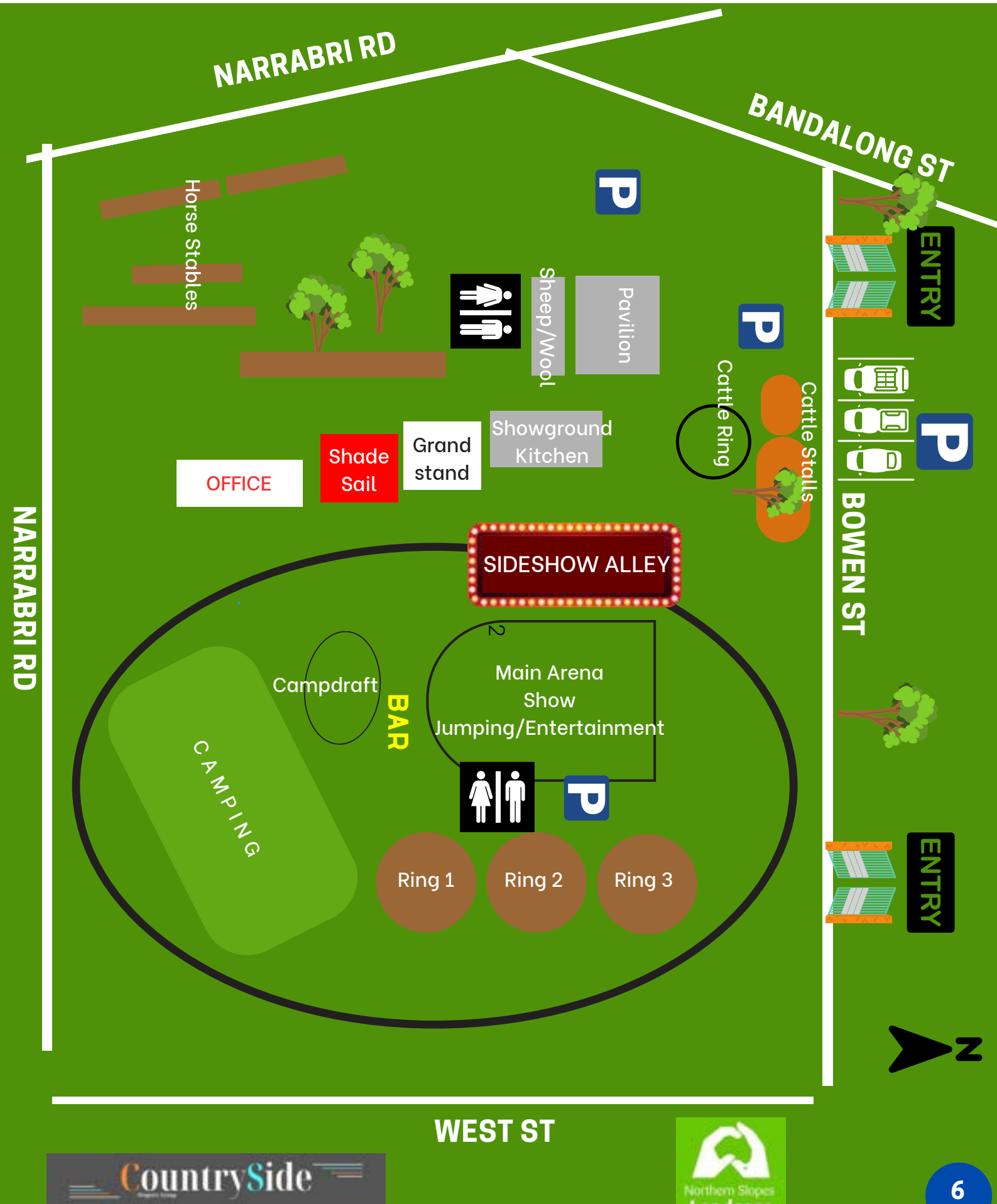

Exhibitors

Pavilion exhibits will NOT be received by the Secretary at his office, excepting those forwarded by post or transport, which must be firmly packed, bearing the senders name, Section and Class No. for which the exhibit is intended. Mailed exhibits will be re-packed and returned after the Show if requested. Postage must be prepaid on all mailed exhibits. All Pavilion exhibits must be staged and presented for judging by midday on Friday, 19th May 2023. Sections closing later are clearly stated at the top of each Section.

Horse stalls: \$10 for the duration of the show. Exhibitors wishing to book stalls for the Show will be required to purchase stalls online via our Facebook page. Industrial stands: Space allocated by Secretary. Charges: \$30 for 3x3m. Trade space application available upon request.

Side Shows: Space allocated by the Chief Sideshow Steward. Charges negotiated with Showmans Guild Representative.

Conditions of Entry

Competitors/Exhibitors hereby agree to abide by any decision of the Society in regard to entries and agree to compete/exhibit at their own risk and to indemnify and keep indemnified the Society against all claims, suits, actions or demands which may be brought against it in respect of any injuries or other losses sustained by them in the course of competing/exhibiting in any event/s and/or class/es and agree to exonerate the Bingara Show Society from all loss or injury whether from alleged negligence or otherwise.

A WAIVER FORM must be signed before any entry for horse/cattle sections are accepted. All competitors/exhibitors are required to have their own Ambulance Cover. The Society will not be responsible for payment of ambulance transport costs.

IMPORTANT NOTICE

To all Competitors/Exhibitors

All persons intending to ride, show animals or offer rides involving animals are required to sign an indemnity form prior to competing.

COMPETITORS are asked to call at the front of the Show Secretary's office prior to competing and sign forms and be given a wristband to show Ring Stewards when competing.

Forms can be downloaded and completed prior to event. Forms are available for:

1. Competitors - over 18 years old.
2. Competitors - under 18 years old - Note: this to be signed by parent or guardian

Important Notice to all Exhibitors

Any exhibitor intending to bring electrical equipment to the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tool and appliances have been inspected and tagged by a licensed contractor. This is essential for the safety of yourself, fellow exhibitors and the general public and is a requirement of the Workplace Health and Safety Act, 2011. The Act imposes severe penalties in the event of non compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Bingara Showground. Please check all your electrical equipment and leads before you come.

Electric leads must be overhead or buried - this is a legal requirement and inspectors will police.

Abuse of Judges and Officials

The decision of the judges shall be final and any competitor or exhibitor who abuses either Judges or Officials and is found guilty, after enquiry by the Committee, shall be disqualified from further participation in this Show. A report shall be immediately forwarded to the North West Group of Show Societies and Pastoral and Agricultural Associations and will result in automatic suspension of the Competitor or exhibitor from all shows for the remainder of the season.

Notice to all Dog Owners

Any dog found loose or wandering will be impounded by the Ordinance Officer. Owners must remove dog faeces and rubbish immediately.

Please note that NO DOGS are allowed on the Showground.

All cattle MUST have an NLIS device fitted and entries to include PIC No. of property of origin. All exhibitors are required to travel with and present a completed NVD with their entries. It is the exhibitors responsibility to make sure their cattle have been scanned in and out.


All bulls over the age of 12 months must have a nose ring fitted. All steers and females to be exhibited with bulldog grips. Age of all exhibits must be up to and inclusive of 20th May 2023. Calves on cows to be under 8 months of age and are ineligible to compete in individual class. Bingara Show Society Incorporated will continue to provide a safe environment for our exhibitors, however you are ultimately responsible for your own biosecurity. You should make your own risk assessment of our facilities and act accordingly. Please use common sense. National Cattle Health Statement must be completed and returned with entries. All exhibitors must have J-BAS 6 to attend.

ALL exhibitors must sign appropriate waivers before handling cattle.

The committee reserves the right to alter program/or join classes together in the event of low entry numbers.

Animal Indemnity Waiver, National Vendor Declaration & National Cattle Health Declaration Forms to be completed and submitted with entries.

ALL RIDERS MUST SIGN A WAIVER FORM AND WEAR AN INDEMNITY BRACELET INTO THE RING, COMPLETED A HORSE HEALTH DECLARATION & A TRANSPORTED STOCK STATEMENT (FORMS AVAILABLE ON THE BINGARA SHOW FACEBOOK SITE).

Registration papers of breed horses must be shown on demand. Ringmaster reserves the right to delete or alter Classes at his discretion. All contestants participate at their own risk and must be suitably attired and equipped for individual events. This society enforces the wearing of suitable ASA approved helmets in horse events. Competitors entering in events that clash must supply another rider.

NEWCOMER: Must not have been shown under saddle or competed under saddle prior to 1st January 2022. Must compete in a snaffle bit.

INTERMEDIATE: A horse that has not been placed first, second or third in any individual hack class at any Royal show. Same applies to Show Hunters.

DISTRICT: All horses must be owned by the rider or immediate family member. Riders must reside in the Shire or go to a school in Bingara. Pony Club uniform or Show class attire to be worn. Helmets with chin strap, smooth sole riding boots. Show hunter or Open horses can compete in District classes and these will not be split.

CHILD AND ADULT HACK CLASSES: Horses cannot compete in both.

SHOW HUNTERS: Cannot compete in Open Hack classes on Saturday. Show Hunters must have been shown as a Show Hunter at the start of 2022. Members classes-Horses must be registered with the Australian Hunter and Show Horse Association and owner/rider must be a financial member to be eligible to compete in MEMBERS classes.

BREED COMPETITORS: All Breed horses must be registered with their relevant Breed Society/ Associations. All Handlers/Riders must also be financial members of the relevant Breed Society/ Association. Registrations/memberships must be produced on request.

JUDGES DECISION: IS FINAL PROTEST: Must be in writing within 10 minutes of class finishing along with \$50 non-refundable.

All rings will be running outside the main arena over on polo fields.

ALL ELECTRIC FENCING NEEDS TO BE IN ACCORDANCE WITH ASC RULES, NO ALCOHOL IS PERMITTED IN THE JUDGING ARENA NO MOBILE PHONES PERMITTED IN THE JUDGING ARENA BY COMPETITORS.

- Yards must be constructed of two strands of conductive tape set at suitable heights to contain the horses
- The tapes should be attached with insulated fasteners to well driven steel pickets fitted with protective plastic caps or the equivalent in plastic or fibreglass
- The tapes must be energised by an Australian standards compliant battery powered energiser (no mains power connection) of sufficient capacity for the fence it is energising
- Each yard should be reasonably square and preferably at least 16 square metres in area
- The fence must be energised whenever a horse is confined in the yard
- Each externally facing fence of each yard must exhibit a sign at least 200mm by 100mm carrying indelibly in a contrasting colour on both sides, in letters at least 25mm high the words "TAKE CARE - ELECTRIC FENCE"
- While electrical connection between yards is permissible, interconnection of actual yards should be avoided
- In the construction of yards, care should be taken to ensure that no situations are created where entrapment of any loose horse or any person could occur where avoidance of electric fence contact is virtually impossible
- All components of the fence must be in reliable functioning order, including a sufficient supply of batteries, maintenance being the responsibility of the horse exhibitor, and the fence function tested after erection/installation is complete.

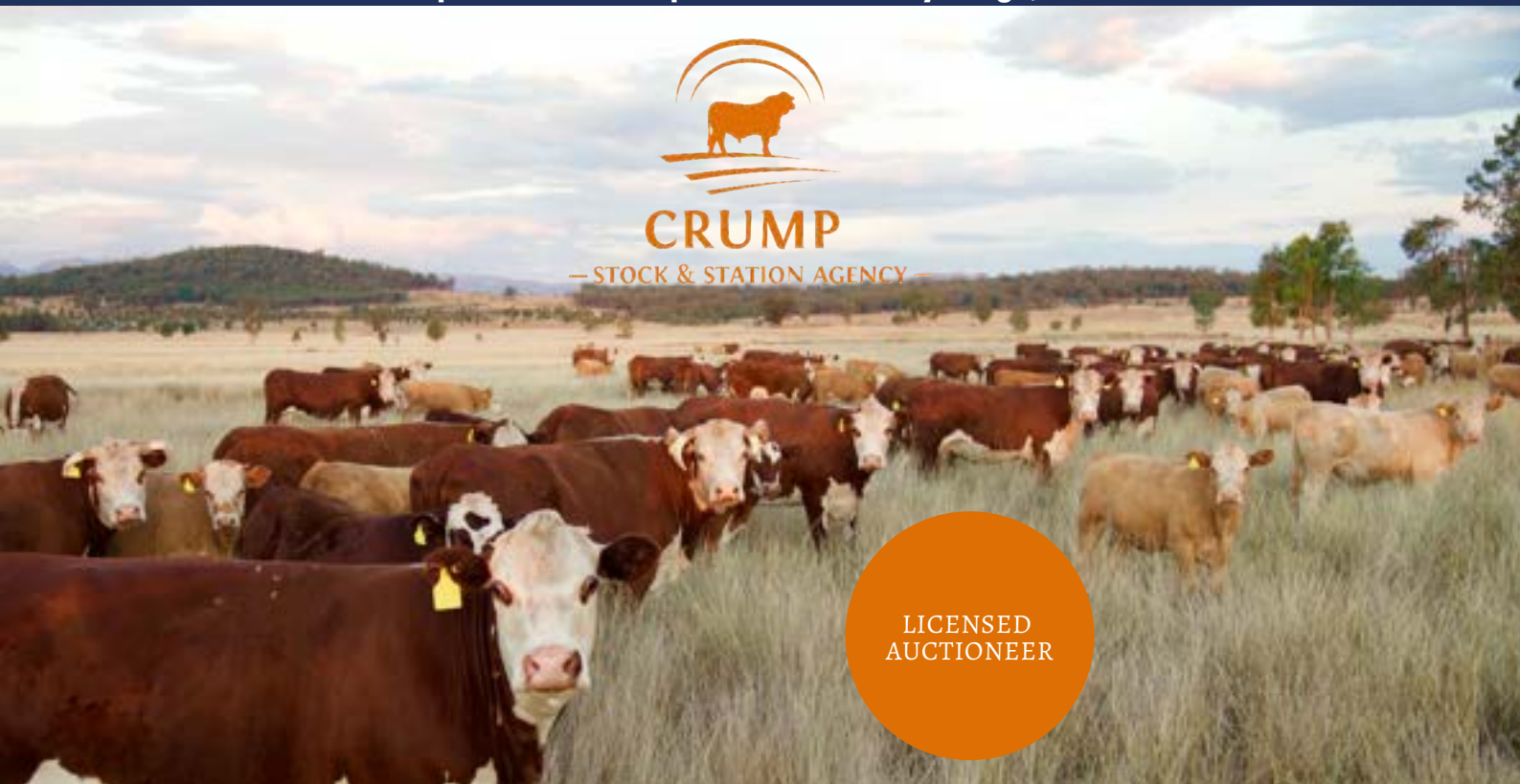
